Preparation for Meeting: Review of 2013 AGM meeting minutes
Prepare for third round deliberations

Brandon called the meeting to order at 09:23

1. Review of 2013 AGM meeting minutes

- a. - spelling error to minutes:
 - i. in 8.c.iii – change “reticulate” to “recirculate”
- b. Brandon: motion to accept minutes with spelling correction
 - i. Bill: seconded
 - ii. All in favour. Minutes accepted.

2. Third Round Deliberations

- a. 2014-003 (Fish Crow)
 - i. female AMCR have variety of courting calls given in spring.
 - ii. female calls should still be more drawn out and not so nasal-sounding.

- iii. where is the line/how do you describe it adequately?
 - iv. is the expansion of the range in ON and elsewhere in NE North America documented well?
 - v. Halton Fish Crow specimen from 2012 confirmed by DNA.
 - vi. paper (<http://www.birds.cornell.edu/crows/nyrange.htm>) discusses history of Ithaca pattern.
 - vii. need to put paper in Ontario birds to discuss pitfalls and variation of FICR/AMCR vocalizations to caution birders from making hasty identifications.
 - viii. on precedent, record includes enough information to accept.
 - ix. **Vote: accept 5-1 (WJC voted no)**
- b. 2014-014 (Fish Crow)
- i. general feeling is description of single call is not sufficient even though date, location, and circumstantial evidence is all suggestive.
 - ii. **Vote: insufficient evidence 1-5 (BRH voted yes)**
- c. 2014-024 (Eurasian Collared-Dove)
- i. really isn't enough to go on in photo. Identification of Ringed vs EUCD is extremely tough.
 - ii. contrast of primaries is variable between birds. Undertail coverts are most important feature.
 - iii. dark web on outer tail feathers – isn't that diagnostic?
 - iv. contrast in primaries doesn't seem obvious enough.
 - v. **Vote: 1-5 (RWW voted yes)**
- d. 2014-028 (Fish Crow)
- i. size difference would be extremely hard if not impossible to see in field.
 - ii. call note **doesn't describe nasal quality**. Single call only (and distant).
 - iii. other FICR records accepted on very little. Same issue as with other reports- where is the bar?
 - iv. **Vote: insufficient evidence 0-6**
- e. 2014-066 (Western Wood-Pewee)
- i. expert comment is not supportive.
 - ii. observer said he heard it 10-15 times. Call/song is very distinctive.
 - iii. photo is definitely a pewee. Voice is distinct.
 - iv. would we accept voice only record?
 - v. seems strange to have a single observer voice-only record from such a heavily birded time/place.
 - vi. voice/description made after the fact. Observer is open to suggestion.
 - vii. for such a rare species and difficult identification need more evidence.
 - viii. are there more photos? Could be helpful
 - ix. seems unlikely that you would pick up a WWPE visually.

- x. agrees; for such a rare bird should tick all of the boxes.
- xi. should try to get closure on record; in letter to observer suggest that record could be re-submitted if there are more photos, etc.
- xii. **Vote: insufficient evidence 2-4 (Bruce and Ross accept)**
- f. 2014-073 (Eared Grebe)
 - i. report rings true.
 - ii. question is lighting – reddish neck could have appeared black in poor lighting.
 - iii. could we treat it just as a record of one since only one description?
 - iv. no fault of observer re: lack of details/late report.
 - v. **Vote: insufficient evidence 3-3 (Ron, Bruce, Bill voted no)**
- g. 2014-074 (Western Grebe)
 - i. already accepted as Western/Clark's. Just need to vote on whether species identification can be made.
 - ii. if report is acceptable, probably can eliminate Clark's.
 - iii. black below eye is specifically mentioned and Clark's was considered. Fact that it is there should be enough to accept.
 - iv. **Vote: accept 6-0**
- h. 2014-091 (Eurasian Collared-Dove)
 - i. difficult identification in flight.
 - ii. there is precedent to accept in flight only records.
 - iii. size should have been obvious – report makes it sound like it was closer in size to MODO.
 - iv. dark undertail coverts reported.
 - v. size should be very noticeably larger than MODO with them nearby for comparison.
 - vi. **Vote: 2-4 (Ron and Bill voted yes)**
- i. 2014-098 (Violet-green Swallow)
 - i. there is another report of VGSW from Port Burwell a couple days earlier (just arrived in mail a couple weeks ago).
 - ii. field sketch was prepared right away. Description is covered well by sketch.
 - iii. colour- would it be obvious given the circumstances?
 - iv. in ten seconds (time stated in Ontbirds post) would that be enough time to see all of the features well?
 - v. level of detail should be possible in ideal conditions
 - vi. suggests it would be straight-forward to identify this species given good but brief looks (it was in his case for first provincial records).
 - vii. will add Ontbirds post to record.
 - viii. **Vote: 6-0**
- j. 2014-118 (White Ibis)
 - i. very straight-forward identification. Don't need thorough description.
 - ii. still a very rare bird in the province.

- iii. observer should have known more details would be helpful. Very short description.
 - iv. **Vote: 5-1 (Brandon voted no)**
- k. 2014-120 (Fish Crow)
 - i. photos show clearly the primary formula of an AMCR.
 - ii. size really is irrelevant.
 - iii. call description is good but photos and circumstances (date, apparent size) are insufficient.
 - iv. **Vote: insufficient evidence 2-4 (BMD and MG voted yes)**
- l. 2014-141 (*Plegadis* Ibis)
 - i. calculated where sun would be- lighting would have been OK.
 - ii. observer is good birder and would know the species well.
 - iii. Consensus: details very sparse but adequate.
 - iv. **VOTE: 6-0**
- m. 2014-174 (Pacific Loon)
 - i. photo is suggestive of juv. RTLO?
 - ii. bill looks better for PALO. Back of crown looks rounded.
 - iii. report is inconclusive so basing vote solely on photo.
 - iv. photo is inconclusive.
 - v. motion to add eBird notes from Josh Vandermeulen's checklist.
 - vi. Carried 7-0.
 - vii. eBird notes from Josh V are acceptable.
 - viii. **Vote: 6-0**
- n. 2014-042 (Lazuli Bunting)
 - i. *Review of Indigo and Lazuli Bunting study skins*
 - ii. definitely some overlap in wing bars and in extent of streaking to breast.
 - iii. rufous colour of wing bars stood out as concerning for Lazuli.
 - iv. variation within the set of photos is evident.
 - v. almost always the upper wing bar was white in the specimens.
 - vi. looks like a Lazuli or hybrid. Can we rule out hybrid or accept without eliminating hybrid?
 - vii. wing bar colour looks a bit buffy, suggesting possibility of a hybrid.
 - viii. most specimens have upper wing bar brighter white; this specimen is the opposite.
 - ix. **Vote: 0-6**
- o. 2014-088 (Carolina Chickadee)
 - i. *Review of Black-capped and Carolina Chickadee study skins*
 - ii. after listening to everyone and looking at specimens thinks there is enough information.
 - iii. good to see the differences in the specimens.
 - iv. not as convinced as he was.
 - v. old specimens not always reliable in terms of colours because of fading and wear.
 - vi. arguments and specimens are convincing
 - vii. **VOTE: 6-0**

- p. 2014-154 (Painted Bunting)
 - i. *Review of Painted Bunting study skins*
 - ii. identification is clear; question is origin.
 - iii. breast colour is unusual; in ROM collection all specimens that were similar were cage birds.
 - iv. showed photo of damaged bill.
 - v. include brief explanation and photos (of bill, of bird, of tray of specimens) in annual report.
 - vi. **VOTE: 0-6 (origin)**

3. Dissenting Member Records

- a. Discussion about Bicknell's Thrush records.
 - i. did we get any other external opinion other than Michel Gosselin?
 - ii. Motion to send both BITH records to Chris Rimmer and ?? Ask Michel Gosselin to do ID article?
 - iii. No motion for re-review was presented.

4. Policy updates

- a. Policy change recommending the annual meeting be held on the first Sunday in March, to prevent a repeat of the issue in 2015 where all voting members were not able to attend any of the proposed dates.
 - i. Current:
 - 1. 4.1. Annual Meeting. An Annual Meeting of the Committee shall be held once a year, **normally during late winter / early spring**, at a time and place set by the Chair, in consultation with the Members. The purpose of this meeting shall be to reach a final decision on all records processed during the previous year, to conduct necessary elections, and for transaction of such other business as may be brought before the meeting. The Secretary must give to all Members prior notice of the Annual Meeting, together with an agenda.
 - ii. Proposed:
 - 1. 4.1 Annual Meeting. An Annual Meeting of the Committee shall be held once a year, **preferably the first Sunday of March**, at a time and place set by the Chair, in consultation with the Members. The purpose of this meeting shall be to reach a final decision on all records processed during the previous year, to conduct necessary elections, and for transaction of such other business as may be brought before the meeting. The Secretary must give to all Members prior notice of the Annual Meeting, together with an agenda.
- b. **Vote: 2-5 (Brandon and Mark voted yes). No changes to be made.**

5. Motions to Change the Review Lists

- a. Delete Pacific Loon from the South review list (submitted by M. Burrell)
 - i. Mike Burrell presented a list of 26 OBRC-accepted records and an additional 9 reports from *North American Birds* (appendix 1) from the past five years.
 - ii. **Vote: 6-1 (Brandon voted no); motion carried.**
- b. Delete Fish Crow from the South review list (submitted by M. Burrell)

- i. Mike Burrell presented a list of 20 OBRC-accepted records and an additional 15 reports published in *North American Birds* (appendix 2) from the past five years.
 - ii. **Vote: 2-5 (Ron and Mike voted yes); motion defeated.**
- c. Delete Kirtland's Warbler from the South review list (submitted by M. Burrell)
 - i. Mike Burrell presented a list of 20 OBRC-accepted records and an additional 13 reports from other data sources (appendix 3) from the past five years.
 - ii. **Vote: 2-5 (Mike and Mark voted yes); motion defeated.**
- d. Delete Green Heron from Central review list (submitted by M. Burrell)
 - i. Withdrawn
- e. Delete Arctic Tern from South review list (submitted by M. Burrell)
 - i. Mike Burrell presented a list of 2 OBRC-accepted records and an additional 24 reports from other data sources (appendix 4) from the past five years.
 - ii. **Vote: 2-5 (Mike and Mark voted yes); motion defeated.**
- f. Delete Glossy Ibis from South Review (submitted by M. Burrell)
 - i. Mike Burrell presented a list of 13 OBRC-accepted records and an additional 6 reports from other data sources (appendix 5) from the past five years, along with records and reports of White-faced (appendix 6) and unidentified *Plegadis* Ibises (appendix 7) over the past five years.
 - ii. Mike: very close to guideline of 20 records, but if you consider the 34 ibis sp. records (of which the majority would be expected to be Glossy) should be well over the criteria. If Glossy were removed, so too would *Plegadis* sp.
 - iii. would we lose reports of White-faced Ibis?
 - iv. Can't make assumption about the *Plegadis* sp. reports.
 - v. **Vote: 3-4 (Mike, Ron, Mark voted yes); motion defeated.**
- g. Discussion of a potential overhaul to the provincial review list system (Brandon)
 - i. All: the consensus was that yes, there are many more bird records that don't get to OBRC. The OBRC should support and encourage the use of existing bird record infrastructure namely eBird and NAB.

6. Other Business

- a. Lumping of FICR records for review purposes
 - i. Was good to review all Fish Crow records together. Suggests an article in Ontario Birds or OFO News (or online) to educate Ontario birders about the identification challenge/pitfalls and how to properly document this species.
 - ii. remind people in Ontbirds post to try to record FICR or other birds they are hearing.
 - iii. do we need to develop a review standard for FICR?

- b. Distribution of “non-accept letters” to the voting members with timelines for their completion.
 - i. Ross, Bill, Mark, Pete all willing to help write letters
- c. Status update on the publication of OBRC records on eBird
 - i. Norfolk records too imprecise
 - ii. working on getting precise locations then will upload full database. Requires going through individual reports (since only nearest town is published in OBRC reports and OBRC database).
 - iii. we are now recording coordinates in database and on coversheets
- d. Status update on the digitization of OBRC records
 - i. Mark Peck has volunteer at ROM plus two other volunteers still working on scanning records. A continued work in progress.
- e. Past use of specimen data sheets
 - i. Bill has blank sheet; will send along for upload for future use as needed.
- f. Issues with round 3 voting
 - i. All went well this year
- g. Review of 2014-2015 changes in voting procedure and use of “voting deadlines”
 - i. worked well this year.
 - ii. much more efficient.
- h. Timelines for the publication of the annual report in Ontario Birds
 - i. June 15 final deadline
 - ii. will send out first draft by end of April at the latest, along with a detailed timeline.
- i. Review of expenses
 - i. send expenses to Brian Gibbons (OFO treasurer)
- j. PIPL records from 2013
 - i. some PIPL records were accepted in 2013 but not published in annual report.
 - ii. will send info to Mike for publication in 2014 report.
