

## 2020 Meeting Minutes

**Members not present: Ken Burrell [KGB] (present only for voting on Item 8b)**

### Agenda:

1. Call to Order – ACG called meeting to order at 0900
2. Minutes of the 2019 OBRC AGM – ACG: motion to approve. Vote: 7-0 in favour.  
Minutes of the 2020 Policy Meeting – ACG: motion to approve. Vote: 7-0 in favour.
3. Business arising from 2019 AGM:
  - a. MVB: noted that the timeline of duties has been slightly updated. He will send around the modified version shortly. All of the tasks in the timeline are already covered in the bylaws (at a high level) so no need to add any specific tasks into bylaws. Decision to keep this document as an informal set of guidelines.
  - b. BNC: BNC worked with Don Sutherland from 2019 committee on proposed amendments to 6.2.3 to cover third party submissions: Remove wording in second sentence, saying that can only be submitted with observer permission. BNC: motion to approve – Vote: 7-0.
4. Third round voting: discussion
  - a. 2020-018 Brambling – Members note that they are generally of the opinion that the observer likely saw the identified species, but the evidence provided is not sufficient. Vote: 1-5. Not Accept-ID insufficient evidence.
  - b. 2020-059 Lewis's Woodpecker – MVB: Discussion on reliability of forty year old memory and sparseness of the report. Many members noting that the species is extremely distinctive. Vote: 5-1. Accept.
  - c. 2020-070 Neotropic Cormorant – Discussion on whether size is enough to rule out DCCO particularly a potential runt of the species. Generally determined that the photos and description are not enough to be able to accept this record. Vote: 1-5. Insufficient evidence.
  - d. 2020-098 Sooty Tern – Discussion on whether evidence is sufficient in light of rarity. Members note that the underwing pattern is described well in report. Features identified are generally considered sufficient to rule out potentially similar species including jaegers. Vote: 5-1. Accept.
  - e. 2020-131 Western Sandpiper – Discussion that the submitted photos are not of the same bird. Expert opinions are mixed. Noted that ID of short-billed dull juv WESA vs bright juv SESA is extremely difficult. Vote: 5-1. Accept.
  - f. 2020-145 Black Swift – Evidence is relatively good for species in question. Report does not eliminate other species sufficiently including Common Swift. Vote: 0-6. Insufficient evidence.

- g. 2020-150 Great-tailed Grackle – APT/MVB: Description is sufficient to rule out COGR, BTGR should not be considered due to no recorded pattern of vagrancy. MVB: Notes that timing is good for the species in Ontario. BNC: Notes that the new evidence is the photos provided in the eBird checklist. General comments that the photos are difficult to assess based on their quality. Experts consulted are 1-3 on whether the bird in the photos and described in the eBird checklist can be identified as a Great-tailed Grackle or as a large grackle species (Great-tailed/Boat-tailed Grackle) with 3 of the experts stating that they cannot rule out Common Grackle based on the eBird checklist and photos provided. Members note that although the observer likely saw a Great-tailed Grackle, the evidence provided is not enough to accept a record of this rarity. Vote: 2-4. Insufficient evidence.  
Discussion moved to considering the possibility of accepting this record as a Great-tailed/Boat-tailed Grackle. More members are in favour of this, not enough for a consensus and acceptance. Vote held on BTGR/GTGR. Vote: 3-3. Insufficient evidence.
  - h. 2020-176 Spotted Towhee – BNC: No colour described in report. MVB: How can a hybrid be ruled out? APT: Call should be enough to consider it a towhee as the report does not describe the individual in terms other than a towhee with spotting on back. Members note that although they generally believe this species was observed, the evidence provided is not sufficient to rule out a hybrid. Vote: 3-3. Insufficient evidence.
5. Other records to discuss (# of individuals and slash species)
- a. 2020-039 - Cinnamon Teal: Male accepted but we need a consensus on whether the female should be accepted as CITE. Alvaro Jaramillo opinion was the female looks good for CITE. Accept female as well. Vote: 6-0 Accept
  - b. 2020-086 - Ruff: Should we combine with record 2020-085? Very similar pattern, not far apart, but a somewhat large time interval between sightings. MVB notes that during that period we experienced very cold weather which stalled migration for many species. Vote: 6-0 in favour of lumping with 2020-085.
  - c. 2020-089 - Rufous Hummingbird: Decision was insufficient evidence but should this be accepted as *Selasphorus* spp.? Consensus was to use Rufous/Allen's as it is more specific than just the genus level. Vote: 6-0. Accept as Rufous/Allen's Hummingbird
  - d. 2020-113 - Tropical/Couch's Kingbird: Submitted and accepted as the "slash" - should this be left as Tropical/Couch's Kingbird or are committee members comfortable with Tropical Kingbird? Evidence inconclusive to separate. Leave as Tropical/Couch's Kingbird.
  - e. 2020-144 - Ancient Murrelet: There is some disagreement on accepting this as Alcid spp., what should be done with it? Majority opinion that this should just be considered Insufficient evidence.
  - f. 2020-156 - Magnificent Frigatebird: Should this be accepted at frigatebird spp.? Discussion that no optics were used and forked-tail not mentioned. Insufficient evidence.

- g. 2020-168 – Slaty-backed Gull: Should this record be lumped with Peterborough/Muskoka bird? Consensus to keep them as separate since there isn't enough evidence to lump them together.
  - h. 2020-174 - Western Kingbird: Should this be accepted as yellow-bellied kingbird spp.? Discussion that there's enough in the report to rule out Tropical/Couch's, should be considered a Cassin's/Western Kingbird. Accept as Cassin's/Western Kingbird Vote:6-0. Accept.

ACG will divide the remaining records up between the committee members once the final records list for 2020 is compiled and circulated.

- 7. Division of age/sex/plumage of each record: ACG will do this for all if someone can help with Dickcissels – MVB offered to help with DICKs.
- 8. Motions to add/remove species from review lists:
  - a. KGB/MVB: Presented criteria and list of species to be removed under 3 possible scenarios for south review list. The scenarios are listed in Appendix 1. Of the three possible scenarios, scenario 1 was generally preferred by the committee members during discussion. MVB recommended that Ruff and Western

Sandpiper also be included in Scenario 1 if it were approved since in reality both of those species would pass the five-year threshold had they been on the review list for the whole past ten years. ACG: Motion to approve. Scenario 1: Vote: 7-0, Scenario 2: Vote: 2-4, Scenario 3: Vote: 1-5. Scenario 1 accepted with Western Sandpiper and Ruff added to list of species to be removed.

- b. KGB: Proposed removals from the Central Review List
    - i. Mute Swan, see Appendix 2. Argument that this species is still rare in central Ontario. ACG: motion to approve. Vote: 2-6. Stays on Review list
    - ii. Carolina Wren, see Appendix 3. ACG motion to approve. Vote: 8-0. Off review list
    - iii. Dickcissel, see Appendix 4. ACG motion to approve. Vote: 8-0. Off review list.
9. Other agenda items
- a. BNC: OBRC report deadline(s) and the possibility and advantages of earlier circulation of voting packages. Agreement from all committee members that this is a good approach and will spread the workload out across the year. Quarterly update and call for reports to OFO's Birdnews would be appropriate and matches seasons – MVB to add to timeline document.
  - b. ACG: Transparency in the OBRC, in response to an email to the chair. Good discussion on way the OBRC might attempt to better engage the greater community; consensus was that opening up the discussion on third round voting portion of the AGM would not allow members to be candid with each other but the remainder of the AGM would be fine (maybe not much interest) to open up somehow – although in person might be tricky as “our” room is usually cramped as is. APT: Something for us to try to improve over the next year or so, possibly with new opportunities with updates to OFO/OBRC website.
  - c. ACG: OBRC content on the OFO website
    - i. Ontario checklist, review lists – ACG: website is quite outdated, OFO will be revamping layout, including the OBRC pages. ACG is updating the checklist and can take care of this.
    - ii. Guidelines for reporting – ACG: Quite old and long, critical eye would be helpful to tackle this task. MVB: Suggests that this page should be completely redone. How-to videos might be a good fit for this.
    - iii. Any new pages? None brought up by committee members.
10. 2020 Bird of the Year voting.
- a. Variegated Flycatcher record will be credited with bird of the year, narrowly beating out Tundra Bean-Goose.

Appendix 1: Proposal: Update the Southern Review List Criteria, prepared by Ken Burrell and Mike Burrell.

### **Current By-Laws**

6.2.4.1. South Review List – As a guideline, species on the South Review List are recorded less than 20 times per five year period on average. For irruptive species that exceed this total in a single year, they must be recorded in at least three of the five years in the period. Any species that clearly exceeds this number in a five year period but lacks proper documentation for the records may be deleted from the list at the discretion of the committee.

### **Proposed Changes:**

Scenario 1.

As a guideline, species on the South Review List are recorded less than the following tiered approach:

- 20 times per five year period, 30 times per 10 year period, or 40 records per 20 year period.

For irruptive species that exceed this total in a single year, they must be recorded in at least three of the five years in the period. Any species that clearly exceeds this number in a five year period but lacks proper document for the, may be deleted from the list at the discretion of the committee.

Scenario 2:

As a guideline, species on the South Review List are recorded less than the following tiered approach:

- 15 times per five year period, 25 times per 10 year period, or 40 records per 20 year period.

For irruptive species that exceed this total in a single year, they must be recorded in at least three of the five years in the period. Any species that clearly exceeds this number in a five year period but lacks proper document for the, may be deleted from the list at the discretion of the committee.

Scenario 3:

As a guideline, species on the South Review List are recorded less than the following tiered approach:

- 15 times per five year period, 20 times per 10 year period, or 30 records per 20 year period.

For irruptive species that exceed this total in a single year, they must be recorded in at least three of the five years in the period. Any species that clearly exceeds this number in a five year period but lacks proper document for the, may be deleted from the list at the discretion of the committee.
